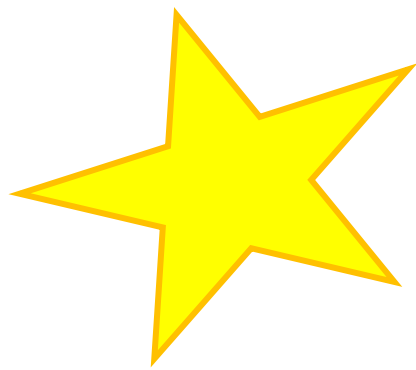

Abraham Lincoln brought it home in the Gettysburg Address.

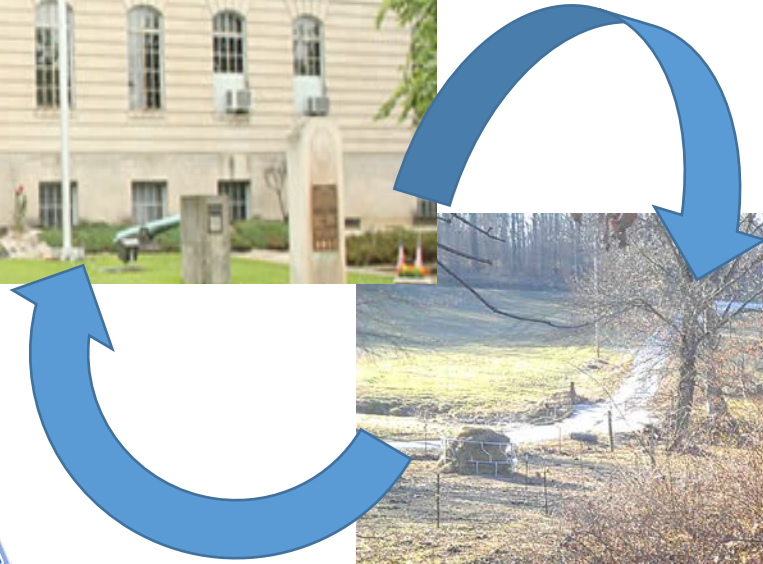
